

**Jack Link's x MrBeast Snack Like A Beast Sweepstakes
Official Rules**

- **NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE OF ANY KIND DOES NOT INCREASE YOUR CHANCES OF WINNING.**
- **MANY WILL ENTER, FEW WILL WIN.**
- **VOID WHERE PROHIBITED BY LAW.**
- **ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION (SEE SECTION 13) AND ENTRANTS (EACH, AN "ENTRANT") WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT (SEE SECTION 12).**

BY ENTERING (OR OTHERWISE PARTICIPATING IN) THE SWEEPSTAKES, YOU AGREE TO THESE OFFICIAL RULES, WHICH ARE A BINDING CONTRACT, SO READ THEM CAREFULLY BEFORE ENTERING. WITHOUT LIMITATION, THIS CONTRACT INCLUDES INDEMNITIES TO THE SWEEPSTAKES PARTIES FROM YOU AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.

1. **ELIGIBILITY:** The Jack Link's x MrBeast Snack Like A Beast Sweepstakes ("Sweepstakes") is open only to legal residents of the fifty (50) United States and the District of Columbia, who are (i) at least eighteen (18) years of age and (b) have or who create an Amazon.com account as of time/date of entry. Creating an Amazon account is free. Employees, officers and directors of Amazon.com Services LLC ("Sponsor"), of Links Snacks Inc., Beast Games, Realtime Media LLC ("Administrator") and each of their respective parent companies, affiliates, subsidiaries, distributors, advertising, contest, fulfillment and marketing agencies (collectively, the "Sweepstakes Parties"), their immediate family members and those living in the same household as such individuals (whether legally related or not) are not eligible to participate in the Sweepstakes or win a prize. For purposes of this Sweepstakes, immediate family members are defined as spouse, partner, parents, legal guardians, in-laws, grandparents, siblings, children and grandchildren and their respective spouses, and those living in the same household shall mean people who share the same residence at least three (3) months a year, whether legally related or not. In the event that a household, based on address, enters the Sweepstakes using more than five (5) unique email addresses, all of the Sweepstakes Entries associated with that household (determined by Sponsor or Administrator at their sole discretion) will be disqualified. All federal, state, and local laws and regulations apply. Non-winning entries made in an Entry Period will carry forward into subsequent Entry Periods. The designated computer clock of the Administrator is the official time-keeping device in the Sweepstakes.

3. HOW TO ENTER: There are two (2) ways to obtain entries in this Sweepstakes:

You will receive one (1) Entry Code per transaction, regardless of the number of eligible products purchased within the transaction. Once you have received your Entry Code, follow the links in the email or directly visit <https://www.jacklinkssweepstakes.com> ("Website"). Log in with your Amazon.com Account credentials and follow the on-screen instructions to complete the registration form, including your email address, phone number, your full address, and your Entry Code to receive one (1) entry (an "Entry") into the Sweepstakes. If you have additional Entry Codes, you may simply return to the Website and log in with your Amazon.com Account credentials and complete a new registration as described above with your additional Entry Code to receive additional Entries, subject to the limit below.

Entry Codes may only be used once and only by one (1) person. Any attempt to obtain Entry Codes in excess of the limits set forth herein may result in disqualification. Entry Codes that are fraudulent, reproduced, altered or obtained outside of authorized channels are not valid. NOTE: ANY FRAUDULENT ACTIVITY IN CONNECTION WITH THIS SWEEPSTAKES IS STRICTLY PROHIBITED. Each Mail-In Entry must be mailed separately in a hand-addressed, stamped envelope. No photocopied or mechanically reproduced entries will be accepted. Sponsor is not responsible for postage-due entries or for any incorrect or illegible data contained in any Mail-In Entry. Mail-In Entries must be postmarked no later than the listed End Date for the applicable Entry Period and received by the listed Mail-In Entry Received By Date for the applicable Entry Period (all dates as listed in the chart above) to be eligible for the Sweepstakes. All Mail-In Entries become the physical property of Sponsor and will not be returned or acknowledged. Mail-In Entries received without a verifiable and legible return address will be deemed incomplete and not valid entries. You will receive two (2) entries for each Mail-In Entry received by the Sponsor. Proof of submission does not constitute proof of receipt.

The Sweepstakes Parties are not responsible for technical difficulties of any kind, or for false, incorrect, changed, incomplete or illegible contact information. For purposes of these Official Rules, Entries and Mail-In Entries will collectively be referred to herein as "Entries" or an "Entry".

LIMIT: Up to thirty (30) total Entries per person during the entire Sweepstakes Period, regardless of method of entry or combination of methods. Attempts made by the same individual to earn more than the stated number of Entries by using multiple or false contact information, accounts or otherwise may result in disqualification. 5. **ODDS:** Odds of winning a prize depend on the total number of eligible Entries received during the applicable Entry Period, plus any non-winning Entries submitted in previous Entry Periods and carried forward.
6. **WINNER NOTIFICATION/PRIZE CLAIMING:** Each potential winner will be notified via email (or other contact information) within three (3) days after the applicable drawing. The Sweepstakes Parties are not responsible for and shall not be liable for incorrect, changed, or illegible contact information or for electronic communications that are undeliverable as a result of any form of active or passive filtering, or insufficient space in Entrant's email or other account to receive messages. Sweepstakes Parties are not responsible for late, lost, intercepted, misdirected, or unsuccessful efforts to notify the potential winner. Notification is deemed to have occurred immediately upon the sending of an email by Administrator. As part of the winner notification process, the potential grand prize winner and each first prize winner will be required to complete and submit a declaration of eligibility/release of liability/prize acceptance agreement ("Declaration"), within three (3) days of date of notification, as a condition of receiving a prize. If a potential winner cannot be contacted within a reasonable time period, if a potential winner is ineligible, if any notification (including the Declaration) is returned undeliverable, if a potential winner declines the prize, or if a potential winner otherwise fails to fully comply with these Official Rules, potential winner will forfeit that prize, and an alternate winner may be selected from among all remaining

eligible Entries received. Up to three (3) alternate winners per prize, after which such prize will remain unawarded. Potential winner becomes an official “winner” only after verification of eligibility by Sponsor.

No more than the stated number of prizes will be awarded. If, for any reason, more bona fide winners come forward seeking to claim prizes in excess of the number of each type of prize set forth in these Official Rules, the winners of the advertised number of prizes available may be selected in a random drawing from among all persons making purportedly valid claims for such prizes. Inclusion in such drawing shall be each entrant’s sole and exclusive remedy under such circumstances.

Fifty (50) First Prizes (awarded only in Entry Period 4): Each “First Prize” is Two Thousand and 00/100 Dollars (\$2,000 USD) made payable to the First Prize Winner. Fifty (50) First Prizes are available in the Sweepstakes and are awarded in Entry Period 4.

One Hundred (100) Second Prizes (awarded in Entry Periods 1, 2, 3, 5, 6, and 7): Each “Second Prize” is One Thousand and 00/100 Dollars (\$1,000 USD) made payable to the Second Prize Winner. One hundred (100) total Second Prizes are available in the Sweepstakes and are awarded in Entry Period 1 (50 Second Prizes), Entry Period 2 (10 Second Prizes), Entry Period 3 (10 Second Prizes), Entry Period 5 (10 Second Prizes), Entry Period 6 (10 Second Prizes), and Entry Period 7 (10 Second Prizes).

The total value of all prizes available to be awarded during the Sweepstakes: \$300,000.

Each First Prize and Second Prize winner will receive a notification email from notifications@mypaymentvault.com with a link to redeem their prize. Winners will have a choice to have their prize awarded in the form of a prepaid card with an expiration date set for six (6) months after prize claim, or a paper check made payable to the winner sent via United States Postal Service.

Prizes are non-transferable, with no substitutions except at Sponsor’s sole and absolute discretion. Prize details, including fulfillment method, are subject to change and are subject to applicable rules and restrictions. Prizes are awarded “AS IS” and without warranty of any kind, express or implied (including, without limitation, any implied warranty of merchantability or fitness for a particular purpose). Each winner will be solely responsible for all federal, state, and/or local taxes, and for any other fees or costs associated with the prize received, regardless of whether it, in whole or in part, is used. The value of the Grand Prize or a First Prize will be reported for tax purposes as required by law. The Grand Prize winner and each First Prize winner will be required to provide Sponsor with a valid social security number before the Grand Prize or First Prize will be awarded for tax reporting purposes. An IRS Form 1099 (preceded by an IRS W-9) will be issued in the name of the Grand Prize winner or the First Prize winner for the value of the associated prize. Any unclaimed prizes will be forfeited. Prizes, if legitimately claimed, will be awarded. The Sweepstakes Parties are not responsible for and will not replace any lost, mutilated or stolen prize or any prize that is undeliverable or does not reach a winner because of an incorrect or changed address. All copyright, trademark or other intellectual property rights in such Advertising shall be owned by the respective Sweepstakes Party and/or its licensors who create the Advertising, and each winner hereby disclaims and waives any claim of right to such Advertising. Such Advertising shall be solely under the control of the Sweepstakes Parties, and each winner hereby waives any claim of control over the Advertising content as well as any possible claims of misuse of winner’s name, likeness or voice under contract, tort or any other theory of law. The Sweepstakes Parties do not assume any responsibility for any disruption in the Sweepstakes, including, but not limited to, the failure or interruption of any social media platform or any internet service provider. In the event there is a discrepancy or inconsistency between disclosures and other statements contained in any Sweepstakes materials and the terms and conditions of these Official Rules, these Official Rules shall prevail, govern, and control. Sponsor additionally reserves the right, in its sole and absolute discretion to modify, suspend or terminate the Sweepstakes should causes beyond Sponsor’s control corrupt or interfere with the administration, integrity, operation, security or proper play of the Sweepstakes.
- 9. CONDUCT:** The Sweepstakes Parties are not responsible for the actions of Entrants in connection with the Sweepstakes, including Entrants’ attempts to circumvent the Official Rules or otherwise interfere with the administration, security, fairness, integrity or proper conduct of the Sweepstakes. The Sweepstakes Parties reserve the right, at their sole discretion, to disqualify (or terminate the prize of) any individual who is found to be, or suspected of, acting in any manner deemed by the Sweepstakes Parties to be in violation of the Official Rules, or to be unsportsmanlike or disruptive, or with intent to annoy, abuse, threaten or harass any other person, or to be tampering with the Entry process or the operation of the Sweepstakes, and void all associated Entries and/or registrations. WAIVERS AND DISCLAIMERS:** The Sweepstakes Parties assume no responsibility or liability for: (a) lost, late, stolen, undelivered, inaccurate, incomplete, delayed, misdirected, damaged or garbled registrations, Entries, URLs, or emails; (b) any incorrect or inaccurate Entry information, or for any faulty or failed electronic data transmissions; (c) any unauthorized access to, or theft, destruction or alteration of Entries or registrations at any point in the operation of this Sweepstakes; (d) any technical malfunction, failure, error, omission, interruption, deletion, defect, delay in operation or communications line failure, regardless of cause, with regard to any equipment, systems, networks, lines, cable, satellites, servers, computers or providers utilized in any aspect of the operation of the Sweepstakes; (e) inaccessibility or unavailability of the Internet or the website or any combination thereof or for computer hardware or software malfunctions, failures or difficulties, or other errors or difficulties of any kind whether human, mechanical, electronic, computer, network, typographical, printing or otherwise

relating to or in connection with the Sweepstakes, including, without limitation, errors or difficulties which may occur in connection with the administration of the Sweepstakes, the processing of Entries, social networking posts, or registrations, the announcement of the prizes, or in any other Sweepstakes-related materials; or (f) any injury or damage to Entrants or to any other person's computer which may be related to or resulting from any attempt to participate in the Sweepstakes. If, for any reason, the Sweepstakes (or any part thereof) is not capable of running as planned for reasons which may include, without limitation, infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes which may corrupt or affect the administration, security, fairness, integrity or proper conduct of this Sweepstakes, then the Sweepstakes Parties reserve the right at their sole discretion to cancel, terminate, modify or suspend the Sweepstakes in whole or in part. If terminated, the Sweepstakes Parties will award the prizes in a random drawing from among all non-suspect, eligible Entries received for the Sweepstakes up to the time of such action.

- 11. RELEASES:** All Entrants, as a condition of participation in this Sweepstakes, release, discharge, indemnify and hold harmless the Sweepstakes Parties and each of their respective directors, officers, employees, agents, successors and assigns (collectively, "Released Parties") from and against any and all liability, claims, costs (including attorneys' fees), losses, damages, fines, or actions of any kind whatsoever for injuries, death, damages, or losses to persons or property which may be sustained, in whole or in part, directly or indirectly, in connection with: (i) participation in any aspect of the Sweepstakes (including travel to/from any Sweepstakes activity), (ii) the receipt, ownership, use or misuse of the prize awarded, including any travel associated with any prize, (iii) the Released Parties' violation of rights of publicity or privacy, claims of defamation or portrayal in a false light or based on any claim of infringement of intellectual property; (iv) Entrant's Entry form material on any related website, or (v) any typographical, human or other error in the printing, offering, selection, operation or announcement of any Sweepstakes activity and/or prize.
- 12. GOVERNING LAW AND LIMITATION OF LIABILITY:** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of Entrants, Sponsor or the Released Parties in connection with the Sweepstakes will be governed by and construed in accordance with the internal laws of the State of Washington, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other laws.

BY ENTERING THE SWEEPSTAKES, ENTRANT AGREES THAT TO THE EXTENT PERMITTED BY APPLICABLE LAW: (A) ANY AND ALL DISPUTES, CLAIMS AND CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THE SWEEPSTAKES, OR ANY PRIZE AWARDED, WILL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION; (B) ANY AND ALL CLAIMS, JUDGMENTS AND AWARDS WILL BE LIMITED TO ACTUAL THIRD-PARTY, OUT-OF-POCKET COSTS INCURRED (IF ANY) NOT TO EXCEED TEN DOLLARS (\$10.00), BUT IN NO EVENT WILL ATTORNEYS' FEES BE AWARDED OR RECOVERABLE; (C) UNDER NO CIRCUMSTANCES WILL ANY ENTRANT BE PERMITTED TO OBTAIN ANY AWARD FOR, AND ENTRANT HEREBY KNOWINGLY AND EXPRESSLY WAIVES ALL RIGHTS TO SEEK, PUNITIVE, INCIDENTAL, CONSEQUENTIAL OR SPECIAL DAMAGES, LOST PROFITS AND/OR ANY OTHER DAMAGES, OTHER THAN ACTUAL OUT OF POCKET EXPENSES NOT TO EXCEED TEN DOLLARS (\$10.00), AND/OR ANY RIGHTS TO HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED; AND (D) ENTRANTS' REMEDIES ARE LIMITED TO A CLAIM FOR MONEY DAMAGES (IF ANY) AND ENTRANT IRREVOCABLY WAIVES ANY RIGHT TO SEEK INJUNCTIVE OR EQUITABLE RELIEF. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY, SO THE ABOVE MAY NOT APPLY TO YOU.

- 13. DISPUTE RESOLUTION:** The parties each agree to finally settle all disputes only through arbitration; provided, however, the Sponsor shall be entitled to seek injunctive or equitable relief in the state and federal courts in the State of Washington, and any other court with jurisdiction over the parties. In arbitration, there is no judge or jury, and review is limited. The arbitrator's decision and award is final and binding, with limited exceptions, and judgment on the award may be entered in any court with jurisdiction. The parties agree that, except as set forth above, any claim, suit, action or proceeding

arising out of or relating to this Sweepstakes shall be resolved solely by binding arbitration before a sole arbitrator under the streamlined Arbitration Rules Procedures of JAMS Inc. (“JAMS”) or any successor to JAMS. In the event JAMS is unwilling or unable to set a hearing date within fourteen (14) days of the filing of a “Demand for Arbitration”, then either party can elect to have the arbitration administered by the American Arbitration Association (“AAA”) or any other mutually agreeable arbitration administration service. If an in-person hearing is required, then it will take place in the State of Washington. The federal or state law that applies to these Official Rules will also apply during the arbitration. Disputes will be arbitrated only on an individual basis and will not be consolidated with any other proceedings that involve any claims or controversy of another party, including any class actions; provided, however, if for any reason any court or arbitrator holds that this restriction is unconscionable or unenforceable, then the agreement to arbitrate doesn’t apply and the dispute must be brought in a court of competent jurisdiction in the State of Washington.
